The Adoption program that is in place at the Cascades Humane Society strives to serve the Jackson area by placing dogs, cats and other animals within the Jackson County area into qualified adoptive homes.

4b (Code:) (Expenses \$ **192,668** including grants of \$) (Revenue \$ **44,936**)

The SNAP program (Spay and Neuter Assistance Program) is designed to help reduce the population of unwanted animals in Jackson County. This program is set up as a low cost assistance program for Jackson County residents who want to bring cats and dogs of all sizes and gender to help control the pet population.

4c (Code:) (Expenses \$ **6,461** including grants of \$) (Revenue \$)

The Pet Food Pantry program is set up to provide pet food to Jackson County residents who are having difficulty meeting the nutritional needs of their cat or dog due to a current financial burden. For any Jackson County resident to be eligible for this program, they must qualify as low income, be a current participant in a state/federal assistance program, or experiencing financial hardship due to the current economic situation. This program exists on donations from the community, and the Pet Food Pantry program is intended to supplement an eligible residents monthly supply of pet food, and not a sole source of their pet's nutritional needs.
